Reference 1.3 Solicitation Process (page 4) – RFP first paragraph amended as follows:

This is a competitive procurement utilizing the Request for Proposal method and as such, award does not have to be given to the lowest priced proposal, but rather to the offeror(s) having a

responsive program that satisfies the procurement criteria or “Best Value” and reserves the right to award multiple contracts resulting from this solicitation.

C2 GPS seeks to procure and compile a listing of approved summer program/camp providers that shall provide allowable, summer camp services that is either offered through in-person, online or a hybrid approach. The list of approved summer camp providers will be used by C2 GPS to refer and match individuals with the appropriate programs/camps.

The application process is open-ended so that potential bidders may submit an application at any time beginning April 24 – July 31, 2023 prior to 3 p.m. (CST). Proposals which have been evaluated, deemed responsive, and accepted will be selected to be placed on the C2 GPS summer camp bidder’s list.

Reference 2.2 Service Contract Term Period and Renewal:

Subject to the availability of funding, ~~the initial contract term period will begin May 15, 2023 and end August 31, 2023.~~ and based on when the approval is made, the beginning contract period will be effective upon award, and have the option to renew for a specified period that will be negotiated in the contract; however, the funding term period will end August 31, 2023.

The Bidder Question period provides the opportunity to request clarification about the scope and nature of the services required or to ask technical questions. Once determined responsive, an evaluation team reviewing independently using a standardized instrument ~~beginning May 10, 2023~~ will evaluate proposals as they are received. The evaluation results will provide a ranking for the proposals from highest to lowest average score that will be used to begin contract negotiations listing of approved summer camp providers that can be contracted to provide summer camp services.
